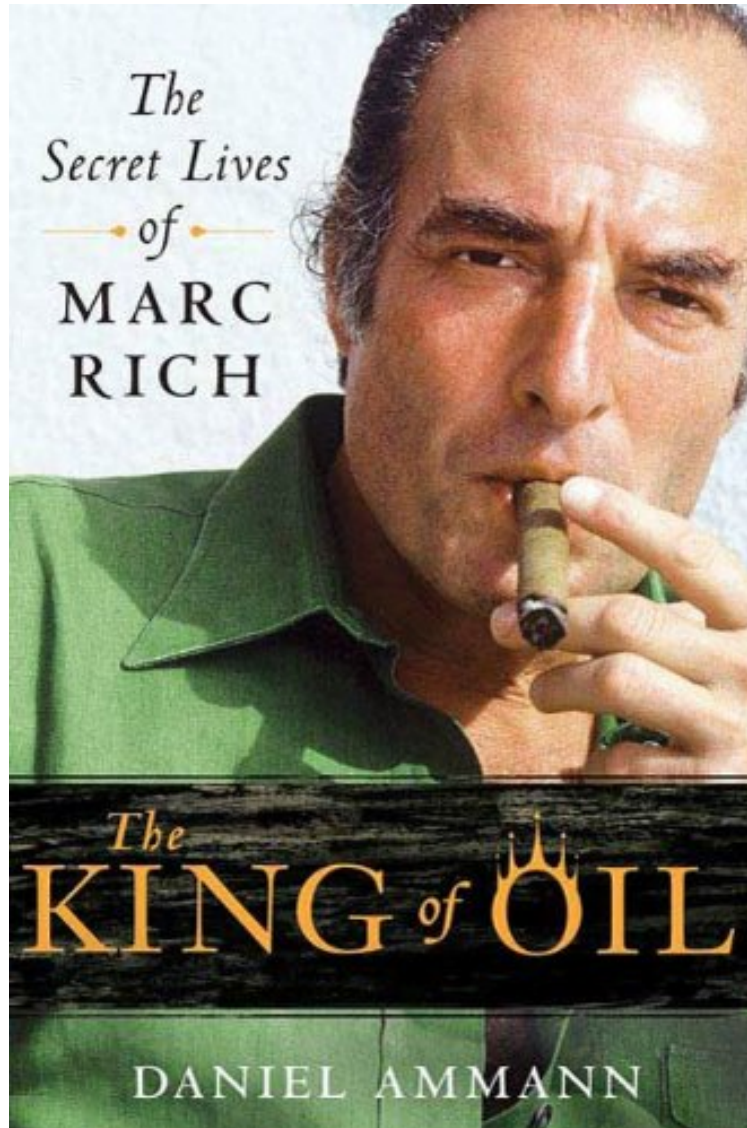

Still, he acquired a net-worth in excess of 2.5 billion dollars. As far as the tax-evasion and embargo-violation charges were concerned and Clinton's pardon (of which the book goes into much too deeply), I think Rich should not have been pursued by the American government.
